	The Complainant also made an Application for Execution of order of the	
	Authority but the same is not granted as the instant Complaint Petition has not	
	been finally disposed of by the Authority as on the date of Execution Application	
	by the Complainant.	
	The Advocate of the Respondent prayed for some more time to make the	
	payment stating that they are facing financial hardship and not in a position to	
	make payment immediately. She also submitted that the director of the	
	Respondent Company could not attend today's hearing due to attack with caugh	
	and cold but she did not produce any medical certificate in support of her	
	submission.	
	After hearing both the parties the Authority is of the opinion that the	
	Respondent is deliberately violating every order of the Authority and submitting	
	lame excuses for non-compliance of the order of the Authority.	

The Authority has no other alternative but to give the following directions:-

- a) As the Respondent has failed miserably to handover the flat to the Complainant they shall refund the Complainant the Principal Amount of Rs.13,13,375/- and interest at the rate of SBI PLR+2% per annum for the period starting from respective date of payments made by the Complainant till the date of realization, as per provision of section 18 of the Real Estate (Regulation and Development) Act, 2016 read with Rule 17 and 18 of the West Bengal Real Estate (Regulation and Development) Rules, 2021, through bank transfer within 45 days from the date of receiving this order through email.
- b) The Complainant shall send their Bank account details to the Respondent within 3 days from the date of receiving this order through email.
- c) In the event of non-compliance of the order the Complainant is at liberty to file an Execution Application on a plain paper as per Execution Regulation.
- d) A penalty of Rs.10,00,000/- is hereby imposed upon the Respondent for non-compliance of the order of the Authority dated 19.11.2024 as per section 61 of the Real Estate (Regulation and Development) Act, 2016. The amount shall be deposited to the WBRERA in the following account:-
