	As per the Complainant she has booked a flat in the 2nd floor of the	
	'Goura Apartment' in the year 2014 from the Respondent Sundar Das (Nitai	
	Naresh). The Agreement for sale was executed between the two parties on	
	03.07.2015. She cannot pay tax in her own name. There is no record in	
	BLRO office in her name and the flat is in the name of the person from	
	which she has purchased the flat. There is no active association. There is no	
	caretaker, day guard, or night guard and permanent sweeper. It's a 5 storied	
	ordinary building where there is no lift too. Recently the maintenance cost	
	has been charged Rs. 1.00 (Rupees one) only per square feet. Earlier it was	
	60 paisa (Sixty paisa) per square feet. The Respondent firmly refused to	
	show the expenditure details when the Complainant asked him to do so.	
	When she refused to pay maintenance, the Respondent disconnected her	
	water supply for a long time in the year 2019. Again in the month of	
i	February of present year he nearly disconnected her water supply by	
	extremely slowing down its force. His personal manager Bapi prabhu also	
	behave in rude manner.	

After hearing the Complainant, the Authority is of the considered opinion that this matter cannot be admitted for further hearing and order u/s 31 of the Real Estate (Regulation and Development) Act, 2016 as the instant flat is a Resale flat that is the Complainant purchased it not directly from the Promoter but from a third party and resale flat does not come within the purview of RERA Authority.

Hence this matter is hereby dismissed on the ground that resale flat is outside the jurisdiction of the WBRERA Authority.
