	It should be mentioned here that by the Order of the Hon'ble Supreme	

Court dated 12.05.2023 in the Case No. Special Leave to Appeal (C) No(s). 16908/2022 in the matter of Saptaparna Ray Vs. District Magistrate North 24 Parganas & Ors., the Apex Court has been pleased to direct—

"This Court observed that the "striking down of WB-HIRA will not affect the registrations, sanctions and permissions previously granted under the legislation prior to the date of this judgment". This principle shall also apply to orders which were passed whether in original or in the course of execution prior to the date of the judgment. All such orders shall be executed in accordance with law, as if they were issued under the RERA.

Moreover, we clarify that all complaints which were filed before the erstwhile authority constituted under WB-HIRA shall stand transferred to and be disposed of in accordance with law by the authority which is constituted under the Central Act. Any person aggrieved by an order passed under WB-HIRA will be at liberty to pursue the corresponding remedy which is available under the RERA."

Therefore, as per the above direction of the Hon'ble Supreme Court the Complaint no. COM 000160 stand transferred to this Authority and this Authority shall now proceed with execution hearing of the final order dated 28.01.2021 passed by erstwhile WBHIRA in this present Complaint Petition bearing no. COM 000160 and execution of the order of Hon'ble WBREAT in Appeal no. 05/2023 dated 04.10.2023, as per the direction of the Hon'ble Tribunal in the said order.

Heard both the parties in detail.

As per the request of the Advocate of the Respondent some time is hereby granted to the Respondent to comply the orders as mentioned above.

After hearing both the parties, the Authority is pleased to give the following directions:-

a) The Respondent is hereby directed to comply the order of Hon'ble WBREAT in Appeal No. 05/2023 dated 04.10.2023 and order of erstwhile WBHIRA in COM 000160 dated 28.01.2021 and deliver possession of one covered car parking space booked by the

Complainant within 31.05.2024 and complete the registration of the said covered car parking space alongwith flat within 30.06.2024.

b) The Respondent is further directed to deposit the fine of Rs.1,000/-(one thousand only) for every day delay, as directed by the Hon'ble WBREAT in its order dated 04.10.2023, starting from 04.12.2023 till the date of registration of the subject matter flat and subject matter covered car parking space in favour of the Complainant and deposit the amount of fine in the Bank Account of the WBRERA as given below:
