	High Court Calcutta vide SMAT 5 of 2025 with CAN 1 of 2025 and Hon'ble	
	Justice Sabyasachi Bhattacharya and Hon'ble Justice Uday Kumar was	

pleased to dismissed the said Appeal Petition without any order as to costs.

The Complainant also stated that he got refund of Rs. 707114/- from the Respondent as delay interest amount after dismissal of the appeal Petition by the Hon'ble High Court at Calcutta. He prayed before the Authority for immediate compliance of the order passed by the Ld. Tribunal on 17.09.2024, vide Appeal Petition No. WBREAT/APPEAL No-007/2024.

The Ld. Advocate on behalf of the Respondent stated that they will file SLP before the Apex Court and prayed more time for the same. He also stated that the Appeal before the Apex Court has not been submitted as on date and therefore, he is not in a position to submit any documents relating to this before the Authority.

After hearing both the parties, the Authority is hereby pleased to give the following directions:-

- A. The Respondent shall comply the order of the Ld. Tribunal vide Appeal Petition No. WBREAT/APPEAL No-007/2024 within **30** days from the date of receipt of this order of the Authority.
- B. If the Respondent fails to comply with the above mentioned order, Respondent Shree Joydeep Majumder, shall appear before the Authority in person and to show cause, why stringent action will not be taken against him for violation of the relevant section Real Estate(Regulation and Development) Act, 2016.

Fix 09.07.2025 for further hearing and order.
