- d) The Complainant shall send his Bank account details to the Respondent through email in which he wants to take the refund amount within 3 days from the date of receipt of this order of the Authority by email.
- e) If the Respondent fails / neglect to make the payment as per the directions (a) and (b) above then penalty shall be imposed as per section 61 read with section 38 of the Real Estate (Regulation and Development) Act, 2016.

The Authority shall review the matter after 3 months.
