	space allotted to the Respondent, in terms of the allotment letter dated	
	25.07.2019 on the terms of condition stated therein. The Agreement for Sale	
	was also executed between the parties. As per the Complainant, the	
	Respondent failed/neglected to make any further payments in spite of several	
	requests and reminders by the Complainant. The Complainant sent a	
	Termination Notice dated 17.08.2022 thereby terminating the said agreement	

dated 24.07.2019. The Complainant prayed for the relief of necessary order to release the said allotment and permission for fresh sale of the said apartment.
