The amount shall be paid in six (06) installments within six (06) months from today. Payment shall be made by bank transfer to the Bank Account of the Complainant; and
- c) Complainant shall provide his bank account details to the Respondent within 3 days from today.

The Authority shall review the matter after six month from today.
