sanctioned plan and therefore he prayed for proper inspection of the same and an interim order of stay upon the installation of further AC units in violation of sanctioned plan.

Advocate of the Respondent stated that all the AC units have been installed as per the sanctioned plan and as per the Rules and norms in this regard and made objection against issuance of any interim order in this regard.

The Authority is of the considered opinion that without a proper inspection done by any Competent Authority no stay order should be given keeping in view of the balance of convenience and inconvenience of the parties.

After hearing both the parties, the Authority is hereby pleased to give the following directions:-

- a) The Chairman, NKDA shall take necessary steps for Inspection of the matter by any competent person / officer of NKDA Department that whether AC units are being installed in the Roof of the Commercial Tower / Retail Rooftop in the project named 'Avenida' situated at Plot no. IIG/7, in Block IIG, within the limits of Action Area II of Newtown, Kolkata, P.S. Rajarhat, District North 24 Parganas, West Bengal, PIN 700156 of the Promoter Company named Tata Housing Development Company Limited (THDCL), in violation of the sanctioned plan.
- b) The **Inspection** of the same shall be made in presence of both the parties of this Complaint Petition.
- c) This inspection shall be done within 15 days from the date of receipt of this order of the Authority through email.
