- b) Respondent shall make all the payments, as directed in the final order of this Authority dated 23.05.2023, within a period of 45 days from the date of receipt of this order of the Authority through email; and
- c) The payments as directed at (b) above, shall be made by bank transfer to the bank account of the Complainant, within 45 days from the date of receipt of this order of the Authority by email; and
- d) The Complainant shall send his bank account details in which he wants to take the refund amount, to the Respondent by email within 3 days from the date of receipt of this order of the Authority by email.
- e) If the Respondent fails / neglects to comply the above orders of the Authority, penalty may be imposed upon the Respondent as per the section 38 read with section 61 of the Real Estate (Regulation and Development) Act, 2016, if the Authority thinks fit to do so on the next date of hearing.

The Authority shall review the matter on the next date of hearing.
