- Respondent is further directed to complete the payment of the instalments in 5 (five) consecutive months starting from **December**, 2023 ending with April, 2024; and
- c) Respondent is also directed to start payment as per the above directions given at (a) and (b) above; and
- d) If the Respondent fails / neglects to comply the above order of the Authority, penalty may be imposed upon the Respondent as per the section 38 read with section 61 of the Real Estate (Regulation and Development) Act, 2016, if the Authority thinks fit to do so on the next date of hearing.

The Authority shall review the matter on the next date of hearing.
