The said period of extension expired on 30.03.2023 but the project is not yet completed and therefore the Applicant herein applied for extension of the Validity of the Registration of the said project;

And Whereas an online hearing has been held today at 12:00 noon and Authorized Representative of the Applicant Company Ms. Deepa Das alongwith three others were present filing hazira through email. At the time of hearing, they have explained the reasons for not completion of the said project within the validity period of the Registration of the said project and prayed for an extension of 12 months to complete the project and handover the same to the Allottees. They also explained that the delay was beyond their control;

And Whereas a Notarized Affidavit-cum-declaration dated 19.04.2023 has also been submitted by the Applicant herein, explaining the reasons for seeking extension of the instant project. As per the Applicant, due to sudden outbreak of Covid-19 Pandemic the project got substantial delayed for the reason of imposition of country-wide lockdown etc. Also non-availability of the labour force at the construction site and non-availability/disruption of the supply chain of construction material accessories and equipments are the reason of delay in completion of the project. The Applicant also stated that, during the 2nd wave of Pandemic, one of the Senior Engineer of the Promoter Company passed away as a victim of Covid-19 and he was In-Charge of the instant project;

Now Therefore after careful examination of the online submissions of the Authorized Representatives of the Promoter Company and supporting documents on affidavit, submitted by the Applicant and placed on record, this Authority is of the considered view that the delay of completion of the instant project is not due to any default or negligence on the part of the Applicant and the extension prayed by the Applicant is urgently required for completion of the said project and handover of the same to the Allottees;

Now Therefore, in exercise of the power conferred under section 6 of the Real Estate (Regulation & Development) Act, 2016, read with Rule 7 of the West Bengal Real Estate (Regulation & Development) Rules, 2021, this Authority is pleased hereby to allow extension of the Registration of the instant project namely 'Marlin The One' from 31.03.2023 to 30.12.2023 for a period of 9 (nine) months;

Secretary, WBRERA is hereby directed to issue the Extension Certificate extending the validity of the instant project for a period of **9** (nine) months;

This period of extension shall in no way affect the Right of the Allottee to claim for interest for delay and compensation for the period of delay in completion of the project;
