	000054 by the erstwhile WBHIRA being operative and the Copy of the same has	
	been served to the Respondent also and the Learned Advocate of the Respondent	
	also confirmed the receipt of the same and further, the Complainant was directed	
	to move before this Authority to further initiate action into the Order No. 3 dated

- b) The Complainant is hereby directed to submit notarized Affidavit mentioning the balance amount along with accrued interest to be paid to him by the Respondent vide Order No. 3 dated 12.02.2021 issued by the erstwhile WBHIRA in Complaint Petition No. COM 000054 and the same should be sent to the Authority as well as the Respondent both in hard and soft copy within **7** (seven) days from date; and
- Order No. 3 dated 12.02.2021 passed by the erstwhile WBHIRA in Petition No. COM 000054 and to submit notarized Affidavit mentioning the schedule payment of the balance amount along with accrued interest to be paid by the Respondent to the Complainant in two installments within 45 (forty-five) days from the date of issue of this Order and the same should be sent to the Authority as well as the Complainant both in hard and soft copy within **7 (seven) days** from date.
