Therefore, the Authority is of the considered opinion that sufficient time and reasonable opportunity have been given to the Respondent to submit his defense and also opportunity has been provided to him to make the payment in installments but the Respondent failed / neglected to take the opportunity and make the payment.

The Authority is of the considered view that the Respondent failed to deliver the possession of the flat booked by the Complainant to him within the schedule timeline as agreed between the parties, therefore, the Respondent is under the obligation to refund the Principal Amount paid by the Complainant alongwith interest @ SBI PLR +2% p.a. for the period starting from the respective dates of payment by the Complainant till the date of realization, as per the provisions contained in section 18 of the Real Estate (Regulation & Development) Act, 2016 read with Rule 17 of the West Bengal Real Estate (Regulation and Development) Rules, 2021.

Hence, it is hereby

ORDERED

- a) that the Respondent shall make refund of the balance Principal Amount of Rs.19,87,798/-(Rupees nineteen lakhs eighty seven thousand seven hundred ninety eight) only alongwith interest @ SBI PLR +2% per annum, calculated on the total Principal Amount paid by the Complainant, for the period starting from the respective dates of payments made by the Complainant till the date of realization, within a period of 45 (forty-five) days from the date of receipt of this order of the Authority by email; and
- b) The payment shall be made by bank transfer to the bank account of the Complainant. The Complainant shall send his bank account details to the Respondent in which he wants to take the payment, within **7** (seven) days from the date of receipt of this order of the Authority by email; and

c) A penalty of **Rs.10,00,000**/-(**Rupees ten lakhs only**) is hereby imposed upon the Respondent Company for non-compliance of the orders of the Authority dated 05.03.2024 and 19.12.2023, as per the provisions contained in Section 38 read with Section 61 of the Real Estate (Regulation & Development) Act, 2016 and the amount shall be paid by the Respondent within a period of 45 days from the date of receipt of this order of this Authority by email and the payment shall be made by bank transfer to the bank account of the WBRERA.
