He mentioned that even though he has received car parking, it is measuring less than what was committed by the Respondent while executing Agreement for Sale and also the Deed of Conveyance. He further mentioned that last year on 31.03.2024 a large chunk of plaster from ceiling broke down damaging his furniture, floor tiles and other belongings. Inspite of informing the Respondent, it is yet to be repaired. He also mentioned that all the rules as mandated by the said Act, was flouted by the Respondent Developer. He mentioned that he is not aware of CC/OC of the said complex as received from DMC (Durgapur Municipal Corporation) as he is not provided with certified copies of the same.
