	The Complaint was lodged during the period when WBHIRA Act was in force and last hearing was held on 07.04.2021 wherein the Complainant was directed to submit Notarized Affidavit in support of her Complaint Petition and the next hearing was fixed 08.07.2021. But as per order of the Hon'ble Supreme Court dated 04.05.2021 (Writ Petition (C) No. 116 of 2019), WBHIRA Act was declared unconstitutional and so WBHIRA Authority was struck down. However in exercise of the jurisdiction under Article 142 Hon'ble Supreme Court directed that the striking down of WBHIRA will not affect the registrations, sanctions and permissions previously granted under the WBHIRA Authority prior to the date of the judgment i.e. 04.05.2021. The Hon'ble Supreme Court, vide order dated 12.05.2023 further clarified that all Complaint matters under WBHIRA regime shall continue to be dealt under WBRERA and all project sanctioned under WBHIRA shall be deemed to be considered as WBRERA project.	
	Hence, as per direction of Hon'ble Supreme Court this Authority is proceeding with this Complaint case under the provision of RERA Act.
