	Complainant stated that out of Principal Amount of Rs. 19,87,798/- he has received Rs.11,00,000/- from the Respondent as on today, though the Respondent was asked vide order 02 (Execution) dated 22.04.2025 to refund the balance Principal Amount by 30.06.2025. He appealed before the Authority for immediate refund of the entire Principal Amount alongwith interest.	
	The Respondent stated that they refunded Rs.1,00,000/- more today i.e. on 28.07.2025 but the Complainant could not confirm the receipt of the same as he could not verify the same in his bank account.	
	The Respondent further stated that due to financial crunches they could not refund the entire amount as per order of the Authority and prayed for some more time to refund the Principal Amount alongwith interest.	
	After hearing both the parties, the Complainant was appraised that the order dated 16.05.2024 may be executed either by the provision of Rule 25 of the West Bengal Real Estate (Regulation and Development) Rules, 2021 by sending it to the concerned District Magistrate for recovery of the amount due as per the provisions of Bengal Public Demands Recovery Act, 1913 or it may be sent to the Principle Civil Court having jurisdiction to execute the same as per the provisions	

of Rule 26 of the said Rules.

The Complainant consented for sending this matter for execution to the District Magistrate of the concerned District in whose jurisdiction the said property is situated, as per the provisions contained in section 40 of the Real Estate (Regulation & Development) Act, 2016 read with rule 25 of the West Bengal Real Estate (Regulation & Development) Rules, 2021.

Therefore, this Authority is hereby pleased to send this matter for execution to the District Magistrate of North 24-Parganas to execute this order as per section 40 of the Real Estate (Regulation & Development) Act, 2016 read with rule 25of the West Bengal Real Estate (Regulation & Development) Rules, 2021. As per rule 25 of the West Bengal Real Estate (Regulation & Development) Rules, 2021, the amounts due shall be recovered by the concerned District Magistrate as arrears of land revenue and shall be recovered in the manner provided in the Bengal Public Demand Recovery Act, 1913 (Bengal Act 3 of 1913) for depositing the same in favour of the Complainant.

The District Magistrate North 24-Parganas, is to execute the order dated 16.05.2024 in WBRERA/COM 000196 passed by this Authority, as per the provisions contained in rule 25 of the West Bengal Real Estate (Regulation & Development) Ru1es, 2021, within a month from the date of receipt of the certified copy of the order dated 16.05.2024 and other documents from the Secretary, WBRERA and send the compliance report to this Authority within six weeks.

It should be mentioned here that in a similar case, the Hon'ble Supreme Court of India, in petition for Special Leave to Appeal (C) No.16908/22, has been pleased to order as follows:-

"We direct, that the Authority shall proceed to execute the order which has been passed in favor of petition expeditiously, within a month from the date of receipt of a certified copy of this order by the executing forum".

As the present matter is similar to that of the matter heard by the Supreme Court of India, as mentioned above, therefore, the Authority directs the District Magistrate of North 24-Parganas, to take necessary action to execute this order within a month from the date of receipt of certified copy of this order along with other papers and documents from this Authority.

Complainant is at liberty to pursue this matter with the office of the District Magistrate, North 24-Parganas to get refund of the amount as per the order of the Authority.
