	The Applicant stated the following in their Affidavit date 31.05.2025:-	
	a) That the Promoter has neither taken any booking nor advertise	

the project till date.

- b) That the Completion date of the project would be 31.12.2027 instead of the date as provided in the application that is 31.12.2026
- c) That the plan has been sanctioned by the Kolkata Municipal Corporation and the copy of the same alongwith Building Permit has been attached with the said Application.
- d) That a fresh FORM B Affidavit has been submitted with this
- e) That the Promoter undertakes to submit additional statements / documents as may be called for by the Authority.

And Whereas, after careful examination of the Notarized Affidavit and supporting documents on Affidavit, submitted by the Applicant and placed on record, this Authority is of the considered view that there is a delay in the completion of the instant project and an extension is urgently required for completion of the said project, for obtaining the Completion Certificate from the Competent Authority and for handover process of the completed flats/units to the Allottees;

Now Therefore, in exercise of the power conferred under section 6 of the Real Estate (Regulation and Development) Act, 2016 read with Rule 7 of the West Bengal Real Estate (Regulation and Development) Rules, 2021, this Authority is pleased to take the decision unanimously to grant the extension of the Registration of the instant project namely 'PASHUPATI APARTMENT' for a period from 01.01.2027 to 31.12.2027. Affidavit to this Authority, both in hard and scan copies, **within 7 days after expiry of every 90 days** from the date of approval of this extension, stating
in detail how much work has been done within the said 90 days and how
much work is pending after the said 90 days.

Authority may conduct inspection at any time without notice to ascertain the real facts and if any discrepancy / misrepresentation come to the notice of this Authority, stringent action shall be taken which may include revocation of extension, as per the provisions contained in the RERA Act.
