	The Respondent did not submit Affidavits as per order of the Authority dated 16.05.2025.	
	Heard both the parties in detail.	
	The Complainant stated that as per order of the Authority dated 16.05.2025, the Respondent did not take any initiative for joint inspection of the property in question and handing over the same including execution of Deed of Conveyance till date. He prayed before the Authority for immediate possession of the flat including execution of Deed of Conveyance.	
	The Advocate of the respondent stated that due to some communication gap joint inspection of the property in question could not be arranged but the flat is almost ready and possession has to be given to the Complainant by 31.08.2025.	
	After hearing both the parties, the Authority is of opinion that the Respondent Company has miserably failed to comply the order of the Authority dated 16.05.2025 by neither submitting the Affidavits nor arranging for joint inspection of the property as per order of the Authority. Therefore, the Authority expressed great dissatisfaction over the activity of the Respondent and is pleased to give the following directions:-	
	 A. The Respondent shall handover the possession of the flat, complete in all respect including execution of Deed of Conveyance within 31.08.2025 positively. A. An amount of Rs. 1,00,000/- is hereby imposed upon the Respondent Company under section 61 of the Real Estate (Regulation and Development) Act, 2016 for non-compliance of the order of the Authority 	

dated 16.05.2025 and shall deposit the same within **45(forty-five) days** from the date of receiving this order by speed post or by email, in the following account of WBRERA.
