The Respondent is further directed to pay penalty as per Section 63 Real Estate (Regulation and Development) Act 2016 for non-compliance of the Authority order at the rate of Rs. **1000/-** per day from the date of final order of the Authority i.e. dated 25.07.2023 till the date of final payment to the Complainant as directed above vide (A).
