	Heard both the parties in detail.	
	The Respondent stated that they have taken all measures for formation of Association submitting application for the same to the competent Authority on the basis of which the competent Authority has been pleased to grant certificate of registration confirming the formation of Apartment Owners Association on 20.09.2025. However, there was a spelling mistake in the name of the Association, for which, application has been given to the competent Authority requesting the necessary correction in the spelling of "Heights", which was erroneously spelled as "Higsts" in the issued Registration certificate and the forwarding letter sent by the competent Authority.	
	The Respondent also stated that they are continuing the regular maintaince and upkeepment of the premises of the project in question till formation of the Association without discriminating any Allottee as per direction of the Authority order dated 12.11.2024.	
	After hearing both the parties and going through the Affidavits, the Authority is hereby pleased to give the following directions:-	
	<ul> <li>A. As the Apartment Owners Association has already been formed by the competent Authority the Respondent shall take all measures for handing over the assets and liabilities of the project to the registered Association after due correction in spelling of the name of the Association by the competent Authority.</li> <li>B. The concerned registered Association shall take necessary action for taking over the asset and liability of the project from the Respondent Promoter as per provision of the relevant Act. Such handing over shall be completed within 60</li> </ul>	

(sixty) days from the date of receiving corrected order form the date of competent Authority.

C. The Respondent shall continue all regular maintenance and upkeepment of the premises till handing over of the project to the Apartment Owners association.

D. The Respondent shall also repair the cracks formed on the building if any, within 60 (sixty) days from the date of receiving this order through email.

With this direction the instant complaint petition is hereby disposed of.
