	Respondent failed to handover the property due to which the Complainant compelled to cancel the agreement on 14.06.2023. The Respondent assured to	
	make full refund within 18 months i.e. by 11.02.2025 but Respondent has only	
	returned Rs. <b>2,20,000/-</b> and has since ceased communication.	
	The Complainant prayed for relief of immediate action to recover his invested amount from the Respondent as per provisions of the Act.
