After hearing both the parties, the Authority is pleased to give the following directions:-

- a) Respondent is directed to complete the refund of the Principal Amount alongwith interest, as per the final order dated 07.09.2023, in 4 (four) equal consecutive monthly installments starting from 15th March, 2024 ending with 15th June, 2024; and
- b) The Respondent shall send a **Interest Calculation Sheet** alongwith the first installment and interest shall be calculated till the date of payment of the first installment provided the payment is completed by the Respondent within 15th June, 2024, otherwise, interest shall be calculated till the date of realization; and
- The refund shall be made by **bank transfer** to the bank account of the Complainant; and
- d) The Complainant shall send his bank account details in which he wants to take the refund amount, to the Respondent by email within 3 days from the date of receipt of this order of the Authority by email; and

The Authority shall review the matter on the next date of hearing.
