- b) Respondent shall submit a Compliance Report on Notarized Affidavit before the next date of hearing, after completion of the works as claimed by the Complainant as mentioned above; and
- c) Respondent shall specifically state in its Affidavit, as mentioned at (b) above, what steps he has taken for receipt of the completion certificate and formation of Association of Allottees as per the West Bengal Apartment Ownership Act, 1972; and
- d) A penalty of Rs.5,00,000/- (Rupees five lakhs only) is hereby imposed upon the Respondent for non-compliance and willful violation of the order of this Authority dated 05.07.2024 and 23.10.2024, as per the provisions contained in section 38 read with section 61 of the Real Estate (Regulation and Development) Act, 2016, and the said amount shall be paid positively by the Respondent within 90 days from the date of receipt of this order of the Authority through email, to the bank account of this Authority through bank transfer and the account details of WBRERA is provided hereinbelow:-
