- b) The Complainant shall submit on Notarized Affidavit his statement regarding the amount of discrepancy amounting to Rs.2,71,000/- approximately, serving a copy to the Respondent, both in hard and soft versions, within 15 days from the date of receipt of this order of the Authority through email or by post whichever is earlier.
- c) The Respondent shall submit their Written Response on Notarized Affidavit in response to the Affidavit of the Complainant and send the Affidavit (in original) to the Authority, serving a copy of the same to the Complainant, both in hard and scan versions, within 15 (fifteen) days from the date of receiving the Affidavit of the Complainant either by post or by email whichever is earlier.
- d) The Respondent shall refund the balance Principal Amount, excluding the alleged disputed amount of Rs.2,71,000/-alongwith interest, as well as the penalty amounting to Rs.10,00,000/- imposed on them as per the final order of this Authority dated 16.05.2024, within 30.06.2025.
