	The Complainants stated that they have not received any payment from the Respondent as per order of the Authority dated 17.01.2025.	
	The Complainants further stated that there was a mistake in their earlier Affidavit, in furnishing the amount of first installment of Bank loan, which shall be Rs. 471910/ The same was already communicated by them through email to the Authority on 20.01.2025. The Complainant is directed to confirm it on notarized Affidavit, which is to be sent within 7(seven) days from today.	
	The Authority is of the opinion that the Respondent has failed miserably to give possession of the flat to the Complainant, for which they are liable to refund the invested amount of the Complainant along with interest as per provision of RERA Act.	
	The Respondent was directed by the Authority order dated 17.01.2025 to refund the invested amount of the Complainant along with interest at the rate of SBI PLR +2% and was also directed to deposit a penalty of Rs. 5,00,000/-(five lakh only) to the account of the Authority but Respondent did not comply the order of the Authority.	
	Now, the Authority is pleased to give the following directions:-	
	A. The Respondent shall refund the booking amount of Rs. 7,50,000/-

B. The Respondent shall also pay a penalty of Rs. 6,00,000/-(six lakh only) for non-compliance of the order of the Authority dated 17.01.2025 within 45(forty-five) days from the date of receiving this order by speed post of by email, in the following account of WBRERA.
