Both the parties submitted at the time of hearing that a mutual settlement has been arrived at between the parties, as per the last order of the Authority, regarding the refund of the Principal Amount of Rs. 3,60,000/- alongwith interest @ 9% amounting to Rs.1,62,000/-. As per the said mutual settlement the Principal Amount alongwith interest @ 9% that is total amount of Rs.5,22,000/- shall be paid to the Complainant by the Respondent in three consecutive monthly instalments and among which Rs.75,000/-has already been paid to the Complainant by the Respondent Company on 18.07.2023. As per the Respondent, the remaining amount of the Instalment of the month of July shall be payable by the Respondent to the Complainant's Bank Account within the end of the month of July.

After hearing both the parties, the Authority is pleased to give the following directions:-

- a) Respondent shall complete payment of the installments immediately as per the mutual settlement arrived at between the parties within September 2023; and
- b) The Respondent shall submit a Compliance Report to the Authority after payment of the total amount of Rs.5,22,000/-within October, 2023; and
- c) The Complainant shall also inform the Authority after payment of the total amount.

The matter shall be reviewed in October, 2023.
