As per the Agreement the flat was stipulated to be handed over within 18 months but now after 8 years the Developer is refusing to give the car parking space and also there is no definite timeline given by him for handing over the possession of the flat also. Besides the Developer promised that he will bear the rent expenses for the Complainant during the period of Development but the Respondent Developer is not bearing that for past 7 years.	
	The Complainant prayed for relief of immediate construction and possession of the flat alongwith the car parking space as promised in the Agreement and also reimbursement of rent payment by the Developer because of temporary shifting of the Complainant for the Development of the project.
