	a) The Respondent Promoter shall send to the Complainant through e-mail the list of Allottees for whom mutations are not yet completed, the extra amount, if any, with breakup to be paid by concerned Allottees for mutation, within <b>15 days</b> from the date of	

- receipt of this order of the Authority through e-mail; and

  Thereafter the concerned Allottees shall pay the extra amount within **15 days** to the Respondent and the Respondent shall complete the mutation within **90 days** from the date of receipt of this order of the Authority through email; and
- c) The Respondent Promoter shall take all necessary steps for proper maintenance of security in the said project including imposing restriction on the entry of stray dogs within the said project; and
- d) Necessary steps to be taken by the Respondent so that the change over time in the DG set can be decreased and shortened; and
- e) A break-up shall be given by the Respondent Promoter to the Allottees for the maintenance charges etc; and
- f) The necessary steps to be taken and the application for formation for Association of Allottees to be done within **90 days** from the date of receipt of this order of the Authority through e-mail.

With the above directions, the matter is hereby disposed of.
