- b) The Respondent is hereby given the last chance/opportunity to submit his Written Response on a notarized affidavit to the Complaint Petition, Affidavit and Supplementary Affidavit of the Complainant and he shall send the Affidavit (in original) to the Authority, serving a copy of the same to the Complainant, both in hard and soft copies, within 10 (ten) days from the date of receipt of the Supplementary Affidavit of the Complainant by him either by post or by email, whichever is earlier; and
- c) The Respondent is also directed to remain present positively on the next date of physical hearing, failing which, the Authority shall have no other option but to proceed with ex-parte hearing and disposal of this matter for the end of speedy disposal of justice as per section 29(4) of the Real Estate (Regulation and Development) Act, 2016.
- d) The Complainant is also directed to submit an Affidavit of Service to the Authority before the next date of hearing.
