	The Complainant purchased a flat (flat no.4E, Block – 4) in Riya Gitanjali Complex of the Respondent through Registration dated 04.07.2019. Initially there were very few minor cracks on walls but later on this crack widen and length of this cracks are getting increased day by day. These cracks are quite noticeable from far on both interior and exterior walls. One of these cracks widen and extended from inner side to outer side of wall which is a clear case of structural damage. Some walls of this flat where affected by dampness causing fading of colours of wall or paint peeling off and dampness is also causing concerned to the health of the occupance.	
	Apart from it there are many defects found in the building including cracks and pot holes on roof surface due to poor workmanship. Moreover there is soil erosion veneath the southern part of block 6 and block 7 causing continuous sliding to the nearby pond.	
	The Complainant prays for relief of awarding monitory compensation for the defects as mentioned if such defects are not properly repaired and rectified by the Respondent.	3
