committed by the respondent in lieu of the payment received from the complainant and further delaying their response upon the issue raised by the complainant of refund of his money paid to the respondent and all relief as enshrined in the said RERA Act 2016 and WBRERA Rules 2021 by submitting general reply to the queries raised by the Ld' Advocate for the complainant and making evasive reply inspite of the fact of receipt of the Affidavit from the complainant and themselves submitting Affidavit in opposition after issuance of this Authority order 2 dated 7th May, 2025 by stating that she is not prepared to answer any more about the queries of the Learned Advocate of the complainant.

The Respondent is not at all prepared to answer anything and the Respondents Advocate joined late after repeated call to them from this office of the instant Complaint hearing and could not give specific response to the any point as raised by the Complainant Advocate.

The Learned Advocate appearing on behalf of the Complainant stated that the Respondent is now trying to harass his client and his client has been suffering mentally so the compensation will be imposed upon the Respondent.

Heard both the parties but due to the non cooperation on the part of the respondent decision could not taken under these compelling circumstances.

The Authority is hereby pleased to direct the Complainant 1(one) week time to submit Supplementary Affidavit (if any) as per the earlier Order No. 2 dated 07/05/2025 before this Authority and to the Respondent both in hard copy and soft copy and upon receipt of either hard/soft copy of the Affidavit from the complainant, the Respondent is hereby directed to submit Affidavit in response to the said Affidavit filed by the Complainant (if any) within 1 (one) week. Both shall address the issue raised by the complainant and the relief sought by him.

The complainant is at liberty to file before Adjudicating office for seeking compensation for his mental agony and harassment against the respondent by submitting his application in **form N**.

Fix 3 (three) weeks from this date for further hearing and order.
