	The Complainant submitted that they have duly served their Affidavit, copy of the Complaint Petition to the Respondent.	
	The Complainant submitted that the Respondent booked a Flat on their project named 'Merlin Oikyo Phase –I'. The have received the C.C., the Respondent/Allottee only paid 1-0% of the total cost of flat which is Rs.2,34,175/- (inclusive GST) for Flat No. GB, Block- 8 of the said Project. Now the Complainant wants to cancel the booking of the said flat.	
	Three chances have been given to the Respondent for complying with the Orders of this Authority but the Respondent has failed to do so.	
	Three issues have been raised :-	
	The cancellation of the booking;	
	2. Forfeiture of the booking amount;	
	3. Why show cause under Section 67 of the RE(R&D), Act, 2016 -	
	Shall not be invoked for willful non-compliance of the Orders.	
	As per the page 38 of the Affidavit filed by the Complainant the last payment was made on $24/7/2023$.	
	The Respondent is absent for three days hearing and the Respondent is	
	hereby directed to show cause as to why Section 67 of RE(R&D) Act, 2016 shall	
	not be invoked against him for willful non-compliance of the Authorities' Order	

Nos. 1 dated 09/4/2025, Order No. 2 dated 16.04.2025 and also the notices served upon him.

The complainant stated that in spite of direction upon him vide Order No. 2 dated 16.04.2025 and non response from his end why the Authority shall not cancel the instant booking of his flat executed between him and the Complainant for Flat No. GB, Block – 8 of the Project named 'Merlin Oikyo Phase – I', and forfeiture of 10% of the booking amount of Rs.2, 34,176/- (inclusive GST).

After hearing the complainant the Authority is hereby pleased to give the following directions:-

- a) Either party is given 7 (seven) days time for their submission, if any; and
- b) The Respondent is hereby directed to show cause within 7 (seven) days as to why the Authority shall not cancel the instant booking of his flat executed between him and the Complainant for Flat No. GB, Block 8 of the Project named 'Merlin Oikyo Phase I', and order forfeiture of 10% of the booking amount of Rs.2,34,176/-(inclusive GST); and
- c) The Respondent shall submit his Written Response on Notarized Affidavit as per Order No. 1 dated 06/02/2025 and Order No. 2 dated 16.04.2025 within 7 (seven) days otherwise the Authority shall have pass an expartee order;

Fix next date on 1st July,2025 for further hearing and order.
