The complainant submitted that he has included Mr Uday Modi, Raj Kishore Modi and 6 others as respondents in his complaint.

The Ld' Advocate for respondents admitted of receipt of order 1 dated 22nd May 2025 and she is also aware of the complaint matters made by the complainant being in receipt of form M and the affidavit from the complainant but she could not satisfactorily reply to the above complaint issue raised by the complainant representative in today's hearing and the earlier hearings. She also could not explain the reasons for the respondent failing respond to the direction upon them by Order 1 dated 22nd May 2025 which make her client liable to attract penalty as mandated under the RE(R&D)Act 2016. She sought a week's time for submitting affidavit in opposition on behalf of the respondent in compliance with the said order 1 dated 22nd May 2025.
