	As per the Complainant, he booked a flat in the project, Vinayak Golden Acres" in Konnagar, Hooghly, developed by the Respondent on February, 2022. As per HIRA Registration the project completion date was 31.12.2023 but four in blocks i.e. 1A, 1B, 2A and 2B, construction continued on 2024 and are even continuing as on the date of complaint. Though agreed to fix grills and aluminum windows with glass, no grill has been attached to the windows of the Complainant and also for other's flats. Apart from it several defects have occurred in toilet, walls, roofs etc., though huge amount of GST money has been paid by the Complainant no GST bill has been provided to him in spite of requests, GST bill not given on legal charges bill, Completion Certificate has not yet been given. In spite of continuation of construction work in the project even today, they are demanding maintenance charges for the months of January, February, March, 2025.	
	The Complainant prays for releif of compensation for harassment, non-fixing of grill in windows and proper repairing and maintenance of different parts of the flats, taking action against the Respondent for not providing GST bill and also for not giving Occupation Certificate.	
	After hearing both the parties, the Authority is pleased to give the following directions: -	
	The Complainant is directed to submit his total submission regarding his Complaint Petition on a Notarized Affidavit annexing therewith notary attested/self-attested supporting documents and a signed copy of the Complaint Petition and send the Affidavit (in original) to the Authority serving a copy of the same to the Respondent, both in hard and soft copies, within 21 (twenty-one) days from the date of receipt of this order of the Authority by email.
