- c) The Respondent is directed to submit his Reply in Notarized Affidavit both in maintainability point within 21 (twenty one) days from day of receiving affidavit of the Complainant both in hard and soft copy to the Complainant as well as to the Authority, after receiving the copy of the Affidavit of the Complainant, whichever is earlier.
- d) The Complainant is at liberty to submit their Rejoinder/Reply in notarized affidavit, if any, within 14 (fourteen) days from the date of receipt of the notarized affidavit /maintainability point from the Respondent with the copy of the same to the Respondent, both in hard and soft version.
