If the Respondent fails to comply the abovementioned order within the stipulated time period, the Complainant is at liberty to submit an Application on a plain A4 paper praying for execution of this order of the Authority, serving a copy of the same to the Respondent.

With the above directions the matter is hereby disposed of.
