He paid total Rs.8,61,415/- (Rupees eight lakhs sixty-one thousand four hundred fifteen only) till date to the Respondent as part of the Consideration Money. Payment made by the Complainant has been dully acknowledged by the Respondent by issuing Money Receipt Vouchers.

The Complainant paid Rs.3,12,500/- (Rupees three lakhs twelve thousand five hundred only) on 12.07.2018 vide voucher no. 2998, Rs. 3,67,335/- (Rupees three lakhs sixty seven thousand three hundred thirty five only) vide voucher no. 8058, Rs.44,643/- (Rupees forty-four thousand six hundred forty-three only) vide voucher no. 1111 and Rs.44,643/- (Rupees forty-four thousand six hundred forty-three only) vide voucher no. 1112.

The Complainant filed payment receipt duly notarized with his written submission.

The Respondent failed to fulfil their obligation to complete the project and offer possession to the Complainant within the scheduled date as per the Agreement for Sale for reasons best known to the Respondent.

The Respondent till date refunded Rs.20,000/- (Rupees twenty thousand only) to the Complainant.

The Complainant prayed for refund of the balance amount of Rs.8,41,415/-(Rupees eight lakhs forty-one thousand four hundred fifteen only) from the Respondent.

After carefully examination of the Affidavit and fact of the case, it is hereby ORDERED

that the Respondent shall refund entire amount of Rs. Rs.8,41,415/-(Rupees eight lakhs forty-one thousand four hundred fifteen only) along with interest at the rate of SBI Prime Lending Rate + 2% from the date of payment by the Complainant to the date of refund by the Respondent within 45 (forty-five) days from the date of receipt of this order by email and the refund shall be made by bank transfer to the bank account of the Complainant.

Complainant is directed to send his bank account details in which he want to receive the refund from the Respondent, within 3 (three) days from the date of receipt of this order by email.

If the Respondent does not comply with the Order within the stipulated period, as mentioned above, the Complainant is at liberty to Pray for execution of this Order before this Authority.

The Complaint Petition is thus disposed of.
