- a) The Respondent no.2 that is HDFC Bank Limited, Garia More Branch is directed to submit another Notarized Affidavit stating clearly the date of inspection of the building and the particulars of sanctioned plan on the basis of which they rejected the loan and also particulars of the plan on the basis of which they approved loan application of some other Applicant-Allottees of the same building on subsequent occasions. This Affidavit shall have to be submitted in original to the Authority with copy to all the parties, both hard and soft version, within 15 days from the date of receipt of this order of the Authority through email.
- b) The Respondent no.2 is also directed to send a Responsible Officer of the Bank on the next date of hearing to explain the matter more vividly if required by the Authority.
