	Complainant stated at the time of hearing he has received till date Rs.3,00,000/- as refunded by the Respondent, Rs.2,00,000/- has been refunded on 02.03.2022 and Rs.1,00,000/- has been refunded on 13.09.2022 by the Respondent. The remaining amount to be refunded by the Respondent is Rs.10,85,500/- alongwith interest as per RERA Act and Rules.

He requested for necessary direction / order for immediate refund / payment of the said amount.

Respondent stated that they require some more time to make the refund and prayed for necessary permission for payment of the amount in 6 (six) equal instalments.

Complainant at the time of hearing stated that he will accept the payment by the Respondent in certain instalments, if it is ordered by this Authority and the payment is made under the supervision of this Authority.

After hearing both the parties, the Authority is pleased to give the following directions:-

- a) In 6 (six) equal consecutive monthly instalments, starting from Novermber,2023 ending with April, 2024, Respondent shall make payment of the remaining Principal Amount of Rs.10,85,500/- alongwith interest calculated on the total Principal Amount at the rate of SBI PLR + 2% per annum for the period starting from the respective date of payments made by the Complainant till the date of realization; and
- b) The refund shall be made by bank transfer to the bank account of the Complainant and the Complainant shall send his bank account details in which he wants to take the payment to the Respondent by email within 3 days from the date of receipt of this order of the Authority by email; and
- c) If the Respondent fails / neglects to comply the above order of the Authority, penalty may be imposed upon the Respondent as per the section 38 read with section 61 of the Real Estate (Regulation and Development) Act, 2016, if the Authority thinks fit to do so on the next date of hearing.

The Authority shall review the matter on the next date of hearing.
