	Agreement for Sale was executed between the parties on 04.01.2020. As per the	
	Agreement for Sale, the delivery of possession of the flat was scheduled to be held

	lakhs eight-five thousand five hundred only) to the Respondent Company for

	for further hearing and order and give the following directions:-	
	The Complainant is directed to submit his total submission regarding his	

Complaint Petition on a Notarized Affidavit annexing therewith notary attested supporting documents and a signed copy of the Complaint Petition and send the original Affidavit to the Authority serving a copy of the same to the Respondent, both in hard and soft copies, within 15 (fifteen) days from the date of receipt of this order through email.

The Complainant is further directed to specifically mention in his affidavit the amount due to the bank at present annexing a statement in this regard issued by the Bank Authority.

The Respondent is hereby directed to submit his Written Response on notarized affidavit regarding the Complaint Petition and Affidavit of the Complainant, annexing therewith notary attested supporting documents, if any, and send the original to the Authority serving a copy of the same to the Complainant, both in hard and soft copies, within 15 (fifteen) days from the date of receipt of the Affidavit of the Complainant either by post or by email whichever is earlier.

Respondent is further directed to submit a refund schedule, according to which the Respondent will make refund of the balance amount of Rs.10,85,500/-, in his affidavit, as mentioned above, specifically mentioning the date and amount of refund to be made in each date.
