- d) The Complainant is directed to file Rejoinder including the details of the payments made by himP, if any, within 1 (One) week after receipt of the same to the Authority and to the Respondent both in hard copy and soft copy.
- e) The Complainant's name in the Cause Title be changed as Akhilesh Prasad instead of Jai Kishan Prasad.
