order of the Authority.

- C. The Respondent company is hereby directed to submit its written response on a notarized Affidavit regarding the complaint petition and Affidavit of the Complainant annexing therewith notary attested/selfattested copy of supporting documents and a signed copy of the complaint petition and send the Affidavit (in original) to the Authority serving a copy of the same to the Respondent both in hard and scanned copy within 4 (four) weeks from the date of receipt of this order of the Authority.
