- b) The Respondent is further directed to make payment as directed in the Order No. 1 dated 20.3.2025 positively within the next date of hearing and to furnish the payment details.
- c) The Respondent is further directed appear in person in the next hearing to show cause why Section 60 & Section 61 shall not be invoked the Respondent for willful non compliance of the RERA Act 2016& WBRERA Rules 2021.
