	Before disposal of the appeal petition by the Ld. Tribunal, Execution proceeding of the instant case was started on 12.09.2023 and ultimately after a series of execution hearing, the Authority was pleased to pass the order, vide order No. (10) Execution 07.02.205, directing the Additional Executive officer, Howrah Zila Parishad to take necessary steps for conducting a physical inspection, preferably by District Engineer, regarding the present position of the remaining construction work.

As per the said report, no light has been fixed at the common areas of the flat, the lift, though installed is not working due to incomplete work and the supply to the common meter has been disconnected by the WBSEDCL Office.

The Respondent stated that some light has been fixed, the lift has been installed but electricity connection with the lift is not done due to nonoccupancy of the flat by the residents and the supply to the common meter has been disconnected by the WBSEDCL for non-payment of electricity bill.

After hearing both the parties, the Authority is hereby pleased to give the following directions:-

A. The Respondent shall complete the fixing of all lights of common areas and electric connection to the lift including its completion and fitness certificate within **3 months** from the date of receipt of this order. He shall submit a notary attested Affidavit to this effect after completion of the said work to the Authority including copy of bills of common meter already paid by the Respondent.
