The final order of this matter was passed on 12.02.2021 by this Authority.</p> <p>The Complainant has filed an application for Execution of the said order of the Authority on 24.06.2023. The Execution application has been received by the Authority on 30.06.2023.</p> <p>Let the said Execution application of the Complainant be taken on record.</p> <p>Complainant is present in the online hearing today.</p> <p>Respondent is absent in the online hearing despite due service of notice through speed post and also by email.</p> <p>Let the track record of due service of Hearing Notice to the Respondent be kept on record.</p> <p>Complainant submitted today at the time of hearing that no amount has been refunded by the Respondent till today and he prayed for immediate execution of the matter as per the provisions of the Real Estate (Regulation & Development) Act, 2016 and rules made thereunder.</p> <p>The Complainant was apprised at the time of hearing that the order dated 12.02.2021 may be executed either by the provision of Rule 25 of the Real Estate (Regulation & Development) Rules, 2021 by sending it to the concerned District Magistrate for recovery of the amount due as per the provisions of Bengal Public Demands Recovery Act, 1913 or it may be sent to the</p>	

Principal Civil Court having jurisdiction to execute the same as per the provisions of Rule 26 of the said Rules.

The Complainant consented for sending this matter for execution to the District Magistrate of the concerned District in whose jurisdiction the said property is situated, as per the provisions contained in section 40 of the Real Estate (Regulation & Development) Act, 2016 read with rule 25 of the West Bengal Real Estate (Regulation & Development) Rules, 2021.

Therefore, this Authority is hereby pleased to send this matter for execution to the District Magistrate of North 24-Parganas to execute this order as per section 40 of the Real Estate (Regulation & Development) Act, 2016 read with rule 25 of the West Bengal Real Estate (Regulation & Development) Rules, 2021. As per rule 25 of the West Bengal Real Estate (Regulation & Development) Rules, 2021, the amounts due that is 3,80,000/- (Rupees Three Lakhs Eighty Thousand Only) shall be recovered by the concerned District Magistrate as arrears of land revenue and shall be recovered in the manner provided in the Bengal Public Demand Recovery Act, 1913 (Bengal Act 3 of 1913).

The Secretary, West Bengal Real Estate Regulatory Authority (WBREERA), is hereby directed to send certified copies of this execution order alongwith final order dated 12.02.2021 alongwith copy of the Complaint Petition to the District Magistrate of North 24-Parganas, within 10 (Ten) days from today, requesting him to initiate a Certificate Case under the Bengal Public Demand Recovery Act, 1913, as per this order of the Authority,

The District Magistrate North 24-Parganas, is hereby directed to execute the order dated 12.02.2021 in COM 000195 passed by this Authority, as per the provisions contained in rule 25 of the West Bengal Real Estate (Regulation & Development) Rules, 2021, within **a month** from the date of receipt of the certified copy of the order dated 12.02.2021 and other documents from the Secretary, WBREERA and send the compliance report to this Authority within **six weeks**.

It should be mentioned here that in a similar case, the Hon'ble Supreme Court of India, in petition for Special Leave to Appeal (C) No.16908/22, has been pleased to order as follows:-

“We direct, that the authority shall proceed to execute the order which has been passed in favour of petition expeditiously, within **a month** from the date of receipt of a certified copy of this order by the executing forum”.

As the present matter is similar to that of the matter heard by the Supreme Court of India, as mentioned above, therefore, the Authority directs the District Magistrate of North 24-Parganas, to take necessary action to execute this order within **a month** from the date of receipt of certified copy of this order along with other papers and documents from this Authority.

Complainant is at liberty to pursue this matter with the office of the District Magistrate, North 24-Parganas to get refund of the amount as per the order of the Authority dated 12.02.2021.

Let the copy of this order be served to both the parties by speed post and also by email immediately.
