

c) The Respondent shall also upload the **Quarterly Update** and latest status of the project in the WBRERA website, within 15 days from the date of receipt of this order of the Authority through email; and

d) Complainant is at liberty to monitor the progress of the work of the project, as per the milestone as directed at (a) above, through an monthly inspection, to be arranged with prior consultation with the Respondent, and in case of any discrepancy she may submit the same before the Authority on the next date of hearing.
