	As per the Complainant, she paid Rs.13,79,919/-towards advance against total	
	Rs.14,41,890/-for purchasing a flat of approximately 734 sq.ft. built up area at the project	
	namely 'SANHITA at Satuli', Kashipur of the Respondent under the area of BL&LRO,	
	Bhangar, District - 24 Pgs. (South), but even after expiry of agreed 36 months with	
	extension of 6 months as per article 4 of the agreement, the Respondents did not deliver	
	the flat. They actually abandoned the project. Agreement for Sale was executed between the	
	parties on 8th May, 2015. The Complainant has been asking for refund since 2021 but the	
	Respondent did not pay though assured. The Complainant is a senior citizen and in need of	
	medical treatment, has been seriously harassed. Advocate's demand notice was also sent.
