Modification of Sanction Plan (01) ----- 12.11.2024	<p>Whereas an Application has been made by the Applicant on 29.10.2024 before the West Bengal Real Estate Regulatory Authority (WBREERA), as per the provision of section 14 (2)(ii) of the Real Estate (Regulation and Development) Act, 2016 (hereinafter referred to as the RERA Act, 2016) for approval of changes / alterations and incorporation of such changes / alterations, on the ground of revision of sanctioned plan, as furnished at the time of project registration with WBREERA Authority, in the project details named '<b>Keventer One</b>', registered vide WBREERA No:- WBREERA/P/KOL/2024/001378 dated 25.04.2024;</p> <p>And Whereas a Meeting of the WBREERA Authority has been held today in the office of WBREERA and detailed discussion has been held regarding this matter and the Notarized Affidavit and relevant documents submitted by the Applicant have been examined thoroughly.</p> <p>And Whereas Notarized Affidavit-cum-Declaration dated 29.10.2024 has been submitted by the Applicant stating the changes to be incorporated in the project details of '<b>Keventer One</b>' and reason for such changes;</p> <p>And Whereas the Applicant Promoter of the project 'Keventer One' Situated at 25, N.S. Road, Kolkata - 700001, has stated that the prior written consent of two-third of the existing Allottees, regarding change / modification / revision of the details of the Project - 'Keventer One', is not required in the present case, as per the provision contained in section 14(2)(ii) of the RERA Act, 2016, as they have not sold / allotted any unit till date.</p>

And the Applicant did not pray for any extension of the completion date, which is 15.08.2031, of the project due to such change / modification of the project details as per the revised sanction plan.

The Applicant also stated in his Affidavit dated 29.10.2024 that such revision of the plan will not infringe any rights, entitlements of any allottees in the project in any manner as there is no Allottee till date in the said project.

After careful examination of the submission of the said Applicant on Affidavit which is placed on record, this Authority is of the considered view that the changes in the project details is due to revised sanctioned plan and written consent of at least two-thirds of the existing Allottees, other than the Promoter, for revision of the sanctioned plan, as per the statutory requirement of section 14(2)(ii) of the RERA Act, 2016, is not required as there is no Allottee till date in the said project.

Now therefore, in exercise of the power conferred under section 14 of the Real Estate (Regulation & Development) Act, 2016, this Authority is pleased hereby to allow the changes in the details of the project as provided below :-
