

#### 4. **Background: WHEREAS**

- At all material times, one Late Rajendra Nath Bhunia, son of Late 4.1 Khirod Narayan Bhunia was the absolute owner of or otherwise well and sufficiently entitled to all that the piece and parcel of homestead land measuring about 9 cotthas be the same a little more or less formed out of Municipal Holding No. 189/176, Kabi Guru Sarani, within Ward No. 118, comprising in Dag No. 535 and 536 under R.S. Khatian No. 70 corresponding to L.R. Khatain No. 71 under Mouza Sahapur, Pargana Magura, J.L No. 8, Touzi no. 93, R.S. No. 179, P.S Behala, Dist. 24 Parganas (South), Kolkata 700038 by virtue of inheritance.
- While enjoying his possession over the said property, the said 4.2 Rajendra Nath Bhunia executed a Deed of Gift on 23.07.1980 thereby transferring a piece or parcel of land measuring about 4 cotthas out of the said 9 cotthas of land in favour of his daughter namely Manju Rani Bhunia, since deceased, by way of gift which was registered in the office of the District Sub Registrar at Alipore and recorded in Book No.I, Volume No.118, Pages 80 to 82, Being No. 3658 for the year 1980 and by virtue thereof, the said Manju Rani Bhunia became the absolute owner in respect thereof.



- 4.3 Thereafter, the said Rajendra Nath Bhunia executed another Deed of Gift on 25.07.1980 in favour of one of his sons namely Swadesh Ranjan Bhunia, since deceased, duly registered in the office of the Sub Registrar at Alipore and recorded in Book No.I, Volume No.25, Pages 66 to 69, Being No. 3652 for the year 1980, and gifted him the land retained by him measuring 5 cotthas of land out of 9 cotthas and by virtue thereof, the said Swadesh Ranjan Bhunia became the absolute owner in respect thereof.
- 4.4 In pursuance thereof, the said Swadesh Ranjan Bhunia duly mutated his name in the records of the Kolkata Municipal Corporation in respect of the share of land owned by him and upon assessment, the same has since been known and numbered as Premises No.189, Kabi Guru Sarani, Kolkata under Assessee No.411180601884.
- A.5 While seized and possessed of the said land, the said Swadesh Ranjan Bhunia, had sold and transferred all that the piece or parcel of 2 cottahs of land to a third party out of the total 5 cottahs. While seized and possessed of the remaining 3 cottah of land, the said Swadesh Ranjan Bhunia died intestate on 17.09.2021, wife being predeceased on 07.05.2017, surviving his two sons namely Shri Vidyarthi Bhunia (the Donor no.1 herein) and Sri Sabyasachi Bhunia (the Donor no.2 herein) as his only heirs and legal representatives within the meaning of Hindu Succession Act, 1956 and thereupon, they became the joint owners in respect of the said 3 cottahs of land in Premises No.189, Kabi Guru Sarani, Kolkata each having an undivided ½ share.
- 4.6 That in the manner aforesaid, Shri Vidyarthi Bhunia and Sri Sabyasachi Bhunia (the Donors herein) are the joint owners, seized and possessed of or otherwise well and sufficiently entitled to land measuring about 3 cottah be the same a little more or less together

with the brick built house standing thereon measuring 700 sq. ft. more or less built up area comprising in Dag No. 535 and 536 under R.S. Khatian No. 70 corresponding to L.R. Khatian No. 71 under Mouza Sahapur, J.L No. 8, Touzi no. 93, 101, R.S. No. 179 formed out of Municipal Premises No. 189, Kabi Guru Sarani, P.S Behala, Kolkata 700038 within the limits of then South Suburban Municipality now Kolkata Municipal Corporation, Ward No. 118, Dist. 24 Parganas (South), morefully and particularly described in the schedule-A written hereunder herein after called as the "said land".

- 4.7 The Donors herein intend to gift an undivided 1/24<sup>th</sup>share (1/48<sup>th</sup> each)in respect of the said land to the Donees herein as morefully and particularly described in the Schedule-B written hereunder and hereinafter referred to as "said undivided share" and in pursuance thereof, the Donees herein through their lawful constituted Attorney also willingly and willfully accepts the said undivided share as and by way of gift.
- 4.8 The said undivided share is free from all encumbrances, charges, liens, lispendences, mortgage of any manner or nature whatsoever and has no acquisition or requisition and no legal proceedings either under Civil or Criminal is pending in any Court of Law in respect of the said floor.

#### **NOW THIS INDENTURE WITNESSETH**

1.1. corresponding to L.R. Khatlan No. 71 under Mouza Sahapur, J.L No. 8, Touzi no. 93, 101, R.S. No. 179 formed out of Municipal Premises No. 189, Kabi Guru Sarani, P.S Behala, Kolkata 700038 within the limits of then South Suburban Municipality now Kolkata Municipal Corporation, Ward No. 118, Dist. 24 Parganas (South), more fully described in the Schedule-B hereunder written and hereinafter referred to as "undivided share" OR HOWSOEVER OTHERWISE the said property now is or are or heretofore was or were situated described bounded, called, known, numbered butted, distinguished TOGETHER WITH all paths, passages, ways, sewers, drains, ditches, hedges, water, water-courses and all other former and ancient rights, liberties, benefits, privileges, advantages, easements, appurtenances whatsoever to the said undivided share belonging to or in anywise appertaining thereto or usually held, used, enjoyed and occupied therewith or reputed to belong or to be appurtenant thereto and the reversion or reversions, remainder or remainders and the rents, issues and profits thereof A N D all the estate, right, title, interest, claim and demand whatsoever both at law and in equity of the Donor into or upon the said undivided share and every part thereof AND all the deeds, pattahs, muniments, writings, evidences of title which exclusively relates to the said undivided share or every part thereof which now are or hereafter may be in the custody, power, control or possession of the Donor or any person or persons from whom the Donor may procure the same without any lawful action or suit at law and TO HAVE AND TO HOLD the said undivided share so to be unto and to the use of the said Donees absolutely forever and free from all encumbrances.

- 1.2. AND THE DONORS DO HEREBY COVENANT WITH THE DONEES as follows:-
  - 1.2.1. That Notwithstanding any act, thing, deed, matters whatsoever made done executed or knowingly suffered to the contrary the Donor now has good right, full power, absolute authority and

indefeasible title to grant, transfer and convey the said undivided share hereby gifted or expressed or intended so to be unto and to the use of the Donees in manner aforesaid.

- 1.2.2. A N D the Donees shall and may at all times hereafter peaceably and quietly hold, possess and enjoy the said undivided share or every part thereof and pay the rents and taxes to the Appropriate Authorities upon getting her name mutated in the office the Kolkata Municipal Corporation and receive the rents, issues and profits thereof without any lawful eviction, interruption, claim and demand whatsoever or any person or persons lawfully or equitably claiming from under or in trust for the Donor or any of their predecessors-in-title and that free and clear and freely and clearly and absolutely acquitted, exonerated, discharged, saved, harmless and keep the Donees indemnified from or against all charges, encumbrances made or suffered by the Donor or any of his predecessors-in-title or any person or persons lawfully or equitably claiming as aforesaid.
