

1. By an Indenture dated 26/10/1951 registered before The Joint Sub Registrar of Alipore and recorded in Book No. I , Volume No. 105 , Pages 178 to 183, Being No. 6763 , for the year 1951 one The Hindusthan Co-Operative Insurance Society Ltd. a joint stock company having its office at 4, Chittaranjan Avenue, Kolkata as Vendor sold transferred and conveyed all that piece and parcel of land measuring 6.34 Cottahs comprised in Plot No. 673 in Block No. O of the Society's New Alipore Development Scheme No. XV, being a portion of Port Commissioners surplus land presently within the limits of the then Corporation of Calcutta now within The Kolkata Municipal Corporation , Ward No. 081 , Police Station – New Alipore , Kolkata – 700 053 , in the District of 24 Parganas to one Hironmoyee Gupta wife of Phani Bhusan Gupta at or for a valuable consideration mentioned thereunder .
  2. After such purchase as aforesaid while seized and possessed of the said **Hironmoyee Gupta** wife of Phani Bhusan Gupta duly applied for and obtained mutation of her name in the records of the then Calcutta Corporation now within the Kolkata Municipal Corporation in respect of the said Premises which was then known and renumbered as Municipal Premises No. 23A/673, Diamond Harbour Road now renamed as Premises No. 26, Biplabi Dinesh Majumder Sarani , Police Station – New Alipore, Kolkata - 700 053 and was enjoying the same free from all encumbrances paying taxes regularly .
  3. The said **Hironmoyee Gupta** , governed by the Dayabhaga or Bengal School of Hindu Law died intestate on 13.12.1997 leaving behind surviving her two sons namely **Sri Sudha Ranjan Gupta** and **Sri Samir Ranjan Gupta** , as her only legal heirs and successors and no other persons or persons as her heirs and successors. Her husband Phani Bhusan Gupta died intestate on 15.12.1977
  4. That our husband/father "**SUDHA RANJAN GUPTA and SAMIR RANJAN GUPTA**" (since deceased), were the recorded joint owners of Premises No. 26, Biplabi Dinesh Majumder Sarani, (Mailing Address 23A/673, Diamond Harbour Road, Kolkata - 700053, within the ambit of the Kolkata Municipal Corporation, Ward No. 81, under **Assessee No. 11-081-14-0032-4**, and absolutely seized and possessed of the same by paying taxes regularly till date.
  5. That said "**SAMIR RANJAN GUPTA**" died intestate on 23.09.1995 leaving behind surviving his wife **Smt. Jayanti Gupta** and only daughter **Smt. Sampa Saha Gupta**, the Deponent Nos. (iv) & (v) herein as his only heirs and legal representative and the undivided half share of the said property left by the deceased devolved upon **Smt. Jayanti Gupta** and **Smt. Sampa Saha Gupta**, in equal shares according to Hindu Succession Act 1956.
  6. That said "**SUDHA RANJAN GUPTA**" died intestate on 03.10.2007 leaving behind surviving his wife **Smt. Subhra Gupta** and one daughter **Smt. Sayanti Dutta** and one

son Sri. Samik Gupta, the Deponent Nos. (i), (ii) & (iii) herein as his only heirs and legal representative and the undivided half share of the said property left by the deceased devolved upon Smt. Subhra Gupta, Smt. Sayanti Dutta and Sri Samik Gupta in equal shares according to Hindu Succession Act, 1956.

7. That after the death of "SUDHA RANJAN GUPTA and SAMIR RANJAN GUPTA", We, "SMT. SUBHRA GUPTA, SMT. SAYANTI DUTTA, SRI. SAMIK GUPTA, SMT. JAYANTI GUPTA and SMT. SAMPA SAHA GUPTA" the Deponents herein, became the joint owners of the said property being Premises No.26, Biplabi Dinesh Majumder Sarani, (Mailing Address 23A/673, Diamond Harbour Road, Kolkata - 700053, within the ambit of the Kolkata Municipal Corporation, Ward N. 81, under Assessee No. 11-081-14-0032-4.
8. That now We intend to mutate our names i.e. "SMT. SUBHRA GUPTA, SMT. SAYANTI DUTTA, SRI. SAMIK GUPTA, SMT. JAYANTI GUPTA and SMT. SAMPA SAHA GUPTA" as "joint Owners" in the records of the Kolkata Municipal Corporation in respect of the said Premises No. 26, Biplabi Dinesh Majumder Sarani, (Mailing Address 23A/673, Diamond Harbour Road, Kolkata - 700053, within the ambit of the Kolkata Municipal Corporation, Ward N. 81, under Assessee No. 11-081-14-0032-4, in place and instead of deceased husband/father: "SUDHA RANJAN GUPTA and SAMIR RANJAN GUPTA".
9. That I do here by declare and say that "There is no othe rlegal heirs and successors of deceased "SUDHA RANJAN GUPTA and SAMIR RANJAN GUPTA" save and except our selves "SMT.SUBHRA GUPTA, SMT. SAYANTI DUTTA, SRI. SAMIK GUPTA, SMT. JAYANTI GUPTA and SMT. SAMPA SAHA GUPTA".
10. That in future, even after granting such "Simple Mutation", if any complain, objection or litigation regarding the legal heirs - ship of "SUDHA RANJAN GUPTA and SAMIR RANJAN GUPTA" arises from any end in respect of Premises No.26, Biplabi Dinesh Majumder Sarani, (Matting Address 23A/673, Diamond Harbour Road, Kolkata-700053, within the ambit of the Kolkata Municipal Corporation, Ward No.81, under Assessee No. 11-081-14-0032-4, then and in such event, The Kolkata Municipal Corporation will be at liberty to "Cancel" or "Revoke" the mutation of the said Premises in our name without giving any notice to us.
11. That the above statements may be relied upon by the K.M.C. Authority but in the event of any suppression of material facts and if some complication arises in future. K.M.C. authorities shall have the liberty to cancel the mutation granted with out any notice to anyone.
12. That we are all citizen of India by birth.

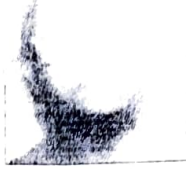
